

Participant Report Back: What we Heard November 24, 2022

Project overview

Over the last five years, The City of Calgary has worked on several projects in the Hillhurst-Sunnyside community. From these projects, we have gathered information regarding how participants view, work and recreate in the area. We have taken that information to update the Landscape of Memory mission and principles. This update will allow future projects to build on work being done so the experience for all users of the space is improved.

Engagement overview

During phase one of engagement in summer 2022, we updated the Landscape of Memory mission and principles to align with what's important to Calgarians and to help guide future planning in the area.

Using the updated mission and principles, the program team identified spaces suitable for future public realm enhancements along the Sunnyside Flood Barrier. As part of our second phase of engagement in fall 2022, the program team gathered input on these public spaces as well as Calgarians' priorities and ideas for other improvements in the area. This engagement ran online from October 15 to November 4 and there were two in-person events – October 15 at the north shore of the Peace Bridge and October 16 at Poppy Plaza.

What we asked

Participants were asked to prioritize five special places along the Memorial Parkway and rate potential improvements & opportunities that had been identified by the program team for each space. These special places include: Calgary Soldiers Memorial, Poppy Plaza, the north shore of the Peace Bridge, the 7 Street N.W. Lookout and the Prince's Island Pedestrian Bridge.

The project team also asked participants for input on potential ideas to re-use Memorial Trees that will be removed as part of the Sunnyside Flood Barrier construction. Lastly, the team asked participants to identify priority areas for potential future mobility improvements for all modes of travel along Memorial Drive.

What we heard

We had over 1000 visitors to the Engage portal page, in addition to more than 100 participants at our inperson sessions. We received 200+ submissions for ranking special places and potential improvements within the Memorial Parkway and almost 200 additional comments related to Memorial Drive mobility. Overall, two main themes emerged in the discussion regarding the parkway. The first was that the pathways should be improved to provide better separation between user groups (i.e. walkers, wheelers, mobility devices). Secondly, participants indicated that they wanted more connection with nature through added features such as more benches, improved river access or more naturalized space.

Below are graphic representations of the feedback from the questions asked, as well as the corresponding themes. Verbatim comments are included at the end of the document. The results are shown as a weighted preference to reflect the priorities participants identified more accurately.

Memorial Parkway Special Places

Question 1. The existing Soldiers Memorial and Sunnyside beach has limited access. How would you like these areas to be improved?




We also asked if there were other ideas we missed. The following is a sample of some of the additional verbatim commentary we received.

- Lighting for the pathway, just enough to light the path
- There's been too much hard scape added to the public spaces along the south side of the Bow River. Try to keep it natural so that there isn't increased runoff during snow and rain events. Think sponge City!
- A toilet on the western side. The nearest ones are on prince's island
- Public art, or perhaps a space for rotating public art to be shown
- A place for seasonal cafe or restaurant by the river or even on the river off of a levee.

Question 2. The existing Poppy Plaza may benefit from Site Activations. How would you like these areas to be improved?




We asked what other ideas we may have missed. Below is a sample of the additional commentary we received.

- The firehall is imposing and appears to be closed 100% of the time. The area feels like a place I'm not supposed to be in. Activation would be great.
- Shade, perhaps put solar over the parking lot. It would give vendors a place to plug in too
- Improve pedestrian experience coming from Sunnyside or Hillhurst into the plaza. Current pedestrian crossing can be intimidating due to speed of vehicles and the pedestrian islands one is required to wait on. It will be hard to truly activate the space considering traffic volume and proximity.
- Public washrooms are needed here and everywhere!

Question 3. The North landing of The Peace Bridge is constrained. How would you like these areas to be improved?




We asked what other ideas we may have missed. Below is a sample of the additional commentary we received.

- If you include seating include bike parking/racks
- NO more large gathering or meeting spaces please!!!! The pathway junction does need improvement as well as more setting perhaps on a natural rock setting down to the river. But no more plazas!!!!!!
- A walkway that extends out over the river edge (like the East Village) because people love taking their picture here. Have a walkway that extends out for good views
- If flood wall must be between river and pathway system please naturalize it as best as possible while also incorporating seating and viewing areas. Preferred location might be between pathway system and road as it will act as a sound barrier and allow a more human forward spaces to sit, wheel etc.

Question 4. The 7th St NW Lookout will be modified due to the Sunnyside Upper Plateau project. How would you like these areas to be improved?




We asked what other ideas we may have missed. Below is a sample of the additional verbatim commentary we received.

- Maintain and improve current separated pathway system. One for pedestrians, one for wheeled vehicles. Do not create multi-use pathways as pedestrians and electrified wheeled vehicles do not mix well. Boat pull out would work well on this island with a pedestrian crossing so close.
- Build a new and expanded outlook cantilevered out over the planned Outfall B48B (Upper Plateau Separation)
- Provide access to Sunny Beach



We asked what other ideas we may have missed. Below is a sample of the additional verbatim commentary we received.

- preserve the big trees as a priority, especially the ones closest to the river that provide shade from the hot south facing sun for all of us who walk home from downtown along this pathway.
- Creating furniture, planting beds or other items for veterans that they would value
- Please minimize any tree removal.

The following are themes of some of the commentaries we received at our inperson events.

As outlined, we received several different types of comments. Many comments received at the in-person sessions overlapped with what we heard online; however, we received additional feedback regarding amenities, usage and types of trees and plantings along the pathway through online submissions. A full list of verbatim comments is at the end of the document.

Memorial Drive Mobility – for Today and Tomorrow

For this portion of the Parkway Program, The City will examine how Memorial Drive and the adjacent public space bordering the Bow River accommodates vehicles, pedestrians, and wheelers today and going forward. It will identify short and medium-term enhancements and explore long-term mobility improvements on and across Memorial Drive. The study will focus on Memorial Drive between 14 Street N.W. and Centre Street N.

We asked participants to use a social map to indicate where they see opportunities to improve walking and wheeling (bikes, e-bikes, scooters, skateboards etc.) on and across Memorial Drive. The feedback received will be shown with maps and sample comments from participants.

Overall, we found that many participants want to see improvements in overall mobility through the area, with many suggestions on what could be done with Memorial Drive. We received several comments about pedestrian and cyclist safety on both the pathways and sidewalks through the area. Additionally, access to












Memorial Drive Mobility - For Today and Tomorrow

- Amenities need to include public washrooms Calgarians deserve clean, safe washroom facilities at frequent intervals along the river paths.

- Who is going to maintain the "natural area" that despite "natural" is riddled with targets? I support a low-maintenance grass/plant palette that is still mowed at reduced frequency and trees actively pruned. Follow the design elements of St Patrick's island for fire pit/picnic table design/layout

However, this is a KEY east west road in our city and we who live nearby do need routes our of our neighbourhoods. Subject: Memorial Parkway project - they aren't listening

Comments: I was just at the public engagement on the Memorial Parkway project. I spoke to the project manager Dan England. Each concern I raised was met with "well we will have to agree to disagree", "not sure how I can convince you" and other comments like this in a very condescending tone of voice. This conversation left me feeling the city is not really wanting to hear our concerns to incorporate them, they are just looking to convince us to get onboard with their plan, just checking the public engagement box. Here are the concerns I raised: Don't want to see huge areas of grass, bushes and trees, especially the big ones which provide much needed shade in our ever-warming climate destroyed in favor of more cement. I saw several other people express the same thing on the post-it notes on the board. • Take a walk down the parkway, hundreds of trees already have an orange dot on them, targeted for removal. Dan says they are targeted for "assessment" but I don't believe him. • Dan was also the project manager for the area on the south side of the Peace bridge. A huge swath of cement with no shade whatsoever which is like walking through a desert on the way home from downtown each day, especially this past summer when we had more days with heat warnings that without. I don't want to see what happened there happen along the Memorial Parkway. • Planting 2 or 3 small trees in place of big, huge trees that have taken decades to grow is not ok. • The city did not plant the 3 promised trees for every big tree they destroyed on the south side project. Dan says they did, but in other areas, again not ok. • These small trees not only don't provide shade for many years, I don't see any birds or squirrels in them at all. They clearly prefer and need larger trees. The beautiful hawks and eagles that frequent the

parkway only land on very tall trees – will we loose them if these big trees come down? I think yes. • On flood mitigation, quoted as the reason for this project, I feel we have done enough good flood mitigation to address the problem with flooding in Sunnyside already. Certainly enough to justify cancelling this project and leaving ALL these beautiful big trees in place. I have lived in Sunnyside for 25 years and was here during the flood in 2013. It doesn't take a scientist to know trees, grass and bushes absorb water and cement does not! • Last but not least, these trees have been planted in memory of soldiers who gave their lives for this county. Tearing them down is completely unacceptable. My Dad was a veteran and before he passed away last year he was very upset about the thought of these trees being destroyed. Terry, I hope by writing this you will take the city to task on this project – hold them accountable to really listen to what we want.

Climate Hub

Prioritize cycling for transportation over cycling for recreation or car traffic.

- 1. Future-proof for increased e-bike commuters with wider pathways
- 2. Eliminate shared multi-modal pathways and replace with dedicated cycling/scooter pathways with pedestrian and bike pavement in distinct colours. On-ground painted icons at intersections is not enough. (See the Netherlands and Germany for examples)
- 3. Revise the ramp to pathway intersection on the north bank of the Bow at the LRT bridge. This is very narrow and a sharp turn that dumps cyclists into a pedestrian area with poor visibility
- 4. Provide clearly separated bike and pedestrian infrastructure at bridges, including Poppy Plaza, Peace Bridge, and Prince's Island Bridge
- 5. Improve Ramp Access @ LRT Bridge and along Memorial Park
- 6. Salvage materials Tree & other items found on site.
- 7. Edible / foraging options in the planting plan
- 8. Garden associations / Taking care of the spaces
- 9. Mental health <redacted due to personal information> (Calgary Homeless Foundation)

Consider adding space for transit stops along Memorial Drive.

Retain natural surfaces as much as possible on the riverbank to withstand flooding (Willow plantings survived better than gravel/hard surfaces in previous floods.)

Use removed trees for wildlife habitat

Improved access to the river will be increasingly important during extreme heat events; provide shade structures or tree canopy for all playgrounds and picnic tables.

Barriers they face to get to and around the program area..

How often do you visit the parkway?

- Maybe once in a while warmer days more often it's not a good place, old bridges and don't' spend a lot of time in the area. Walking some areas used to use the area a long time ago cycle the areas once in a while. I have spent several times in the area, when you walk, you get to see the City, the downtown and I like that walkway on the one side you can see the old houses and the new bridge, but is seems that it's been vandalized, which is silly. So without that bridge how do people get across the river?
- I want to encourage people to get down there, it's a very powerful place. So when I was first married and moved to Calgary, so why don't I just bike, I worked in the SW and lived in the NE. I rode my boke and loved the river. AT the time it didn't feel far, but it is far. The police stopped her one time

and asked if they have a license for the bike, apparently you needed one and the officer waived the ticket. When family visits, I like to take them down there and show off the area, the paths, the shops.

- How easy is to access the river?
- Need steps down to the river
- Do you feel safe in the parkway area?
- Hard to be there with no washrooms, benches are not shaded
- Constantly looking over my shoulder as I can't hear the bikes it's not safe and bikes and walkers need to be kept separate.

Are there any challenges to access the river promenade?

- Are there stairs?
- Poppy Plaza towards Peace Bridge:
- Difficult to find a public washroom and difficult to find a place to fill your water bottle. There is not place to fill your water bottle in the public space. All of the washrooms are locked, they locked them to keep the homeless out, but it limits people. IF the bathroom is closed then fewer people will want to go. There could be patrols so that people could go to the bathroom.
- In Banff, they have blocked the road off and they have public washrooms outside of the locked off area.
- Where the benches are for sitting, there is no shade. You are in direct sunlight there is very few shaded areas to sit and enjoy the space (like Prince's Island)
- Need places to scoot/roller blading
- Places to put bags for the dog poop along the pathway.
- North side of Peace Bridge:
- More seating along the pathway to relax and watch the river flow, especially if you want seniors
- I like to walk, my brother doesn't, so we need to stop more frequently and so we need more seating along the space if I want to spend time with him on the pathway.

7th ST outlook

Prince's Island Pedestrian Bridge

- No recognition of any Indigenous history anywhere along the pathway so that people can understand and appreciate it
- Make sure all the wayfinding is user friendly some people can't afford data plans, some do not speak English (need ESL and ASL for the wayfinding)
- That's new to me to be able to see a translation on an app.
- Not everyone knows what a QR code is.
- It would be nice if there was a way to be able to cross all directions like Banff at the intersection of 10th and Memorial. That's easier for people who are Deaf. People speed in that area there needs to be something to reduce speed in the area. You can rent the scooters and just drop them and that's difficult to navigate and there has to be some way to make people put them away and not leave them on the pathway.



- Because there is a time limit, people just park the scooters when their time runs out.
- AS long as my two feet keep me moving, I'm ok.
- Is there anything that is close to the area that is water proof and will stay safe.
- Can we put more rocks in the river bank? What sort of flood barrier will it look like?
- So it will look like Holland the same idea? They have done some wonderful dams and have done a lot of work on them.
- When the flood happens in this area here (Poppy Plaza) if it was water proof it would save the city money.
- What does 1:100 mean? It doesn't always mean 1 to 100
- And Springbank building that dam, will that help?
- If it floods, is there a lighting system there to warn pedestrians others can hear a warning system, but we can't hear them. Some places have posts that light up if there's a disaster (flood etc).
- It's a good thing CEMA is coming November 22nd for the community survey.
- It's not outrageous technology find something similar for those who are deaf as those who can hear.
- Confederation Park there was a bridge there and someone had a picture of a 16yr old boy who
 was killed when they were struck by a bicycle this needs to be dealt with people are speeding
 along, scooting, skateboarding it's dangerous for those who cant' hear people coming behind
 them.
- Cars have to be patient, they can wait while people cross.
- I am looking around the bridge if there could be a pedestrian overpass at the Peace Bridge. I think that would be better so that you can cross over onto the street.
- A place where kids can have water fights. Where are people going to park if they want to go to the beach? Along this pathway more public art we need way more public art something that gives the variety, some of the other cities in other countries have very unique public art which prompts conversation.
- More lighting on Canada Day and in the late afternoon in mid afternoon it can be a bit dark and in terms of safety it needs to be a bit more light – to sign to communicate and if they need to be able to see.
- What about sensors that would come on if you just come through the area. People can use their lights on the bikes/scooters.
- It would be nice if we had sensor lights along the pathway.
- Are we thinking about a beach parkade for the beach?
- All the garbage that will come if we have fire pits along the area people aren't careful about cleaning up after themselves.
- When people talk about bench seating would we add shade to some/all of the benches? If we get stuck in the rain with kids, where can we go to be protected?
- No seating anywhere else along the pathway. While it is better than it was, there is still a lack of seating along the pathway.
- Nice to have water fountains to fill your water bottles if you're walking/biking. Something as well to ensure people and pets have access to water while they are on the pathway.



- On youtube in England where they have a bathroom, so you are cordoned off and you walk in and the bathroom is portioned off. You can't poop in them though.
- The doors will close as soon as you go in and then when you go to leave the doors open. I'm sure it's expensive. So many good design ideas on youtube it would be nice if our city was better than some of the other cities.
- Does the barrier go all the way to Bowness?
- Are you allowed to use paddle boards in this area and where are there resting areas for paddleboarding
