

Very excellent plan, but please re-route bike lanes behind bus stops, like on Bowness Rd NW, rather than in front. Cycle lanes behind bus stops is best practice & has many benefits. Raised sidewalks on more intersections. Ensure cycle lanes through the underpass are separated & protected from cars.

Looks great but ensure cycle tracks and pedestrians do not collide with each other or traffic (including bus stops)

Really pleased to see The City take the time to redo the existing vision that failed to support safe space for wheeling. Well done. My key advice on the wheeling facilities is to do bus stop bypasses like on Bowness Road in Montgomery. These are safer and more efficient for all users.

Please analyze plan, specifically to improve pedestrian and cyclist safety at intersection southbound 8th Street at 12th Avenue (by Safeway)

Potential daycare pickup/dropoff @alleyway between U of C & convenience store. *pedestrian conflict with vehicles coming out of the lane

Suggestion for underpass, grade separate cars, bikes and sidewalk. Having the cycle lane higher than cars would be safer and easier to use as cyclists don't need to pass with the same clearance.

Absolutely do not make the same mistakes as with 17th Avenue. Clear 2.5-4 metre unobstructed sidewalks are a must for the entire project length on both sides of the street. Raised wheeling and loading zone signage must be clearly marked. No parking/stopping at any time.

Make sure that the cycle track is constructed so that water cannot pool and create ice. Don't contract the snow clearing of the cycle track to one company and the sidewalk to another so there's furrows. Make the intersections safe. Also, ban right on reds on 8 st since there is more biking.

It would be nice to have protection for the bike lane from vehicles.

Maybe adding more barriers on the bike lanes. And a sense of continuity throughout the whole street

Please focus on providing protected cycle lanes from Bow River to downtown. This will help encourage more cycling commutes.

The design overall is generally really good. However, there are no real protected cycling intersections which is a major disappointment. Especially in an area where there are so many conflicts with vehicles and pedestrian accidents.

I love most of these designs. This is a huge improvement and reflects a lot of the feedback I shared previously. I want to see the crosswalk lights on 13th Ave replaced with proper stop lights. Can the cycling infra continue south of 17th?

"Dedicated bike and wheel facilities for most of the corridor" please change "most" to "all". Please include raised crosswalks at all intersections, not only 16 Ave. And please please please line up the crosswalks with the sidewalks so a person can walk/wheelchair/etc in a straight line! Great job!

I don't know why you haven't made all the bike underpass paths like how it is on 4th st se. The dip down with the cars makes things unnecessarily dangerous and challenging for slower riders. You did one logically, why not all of them?

I would like to request that a two-way cycletrack be looked as an alternative to the two one-way cycletracks. While one-ways are often portrayed as superior to two ways, I've found that two-ways fair significantly better in the winter and seem to be more effectively cleared of ice and snow.

Consider adding a smooth top lift to at grade cycle track for smoother ride especially when money invested

Please focus on the streets and sidewalks first - the park at the north side is not a priority.

I think the focus should be on the parts where we can drastically improve things, like adding bike lanes and trees. The minor improvements for pieces that are already working, like Tomkins Park, might be more work than it's worth in the end.

The street itself is mostly fine, probably just need some greenery (nice to have), sidewalk fixed, widening the walkways a little. It's not the exact centre of CBD, upgrading it too much feels too unnecessary since the neighborhood isn't purposed as very commercial currently.

These are welcome improvements but I continue to be confused by this city's allergy to wide sidewalks. Geographically constrained and dense cities like Tokyo and New York are

generous with pedestrian space; it's baffling why two people cannot comfortably cross paths with two other people in Calgary.

Add wayfinding and better lightning.

Need more shade, need asphalt to be painted white, need green roof tops.

Please prioritize the climate emergency in your decision-making. Globally we are falling SO SHORT of targets. We need bold action now. That means low-carbon travel, shade to make walking and biking comfortable, and attractive spaces that make the transition feel great.

Safety is primary. Bicycles and scooters are overtaking the narrow sidewalks putting the safety of pedestrians at risk. Transit stops need to be redesigned with safety and convenience to users. The entire street needs more of a human scale. Crossings at 11th Ave are unsafe. Improve lighting.

It is vital to provide separating for all modes from each other (walking, cycling, driving) as their speeds, expectations and vulnerability differ widely.

I am SO happy the city is working on this. I drive and/or walk 8th st sw every day - every day I have to be extra alert to prevent incidents. It is currently not a comfortable or safe street to use for cars, pedestrians, or other users - these improvements will be a drastic positive impact.

Seek out other org and city departments (not just police) to help with social probs such as sales/use drugs/alcohol. Ongoing prob for 40 yrs. Activations like free concerts & Beakerhead are great & provide opportunities for all members of community to use & enjoy the space.

A more balanced and green approach is very much welcomed for 8th Street which is tired and un-inviting. I'd recommend however, more retail and cafes to make it a destination for the Beltline demographic. My fear is that little used public parks will just attract more vagrants and drug affected.

I think the safety of Tomkins park (for vehicles and pedestrians/cyclists) should be a priority. The narrowing of 8th st for trees is unnecessary. Removing walking obstructions is a great idea! It needs to be made safe for walking at night and in ICY winter conditions.

Fix the scary CRACK MACS corner!!!!! myself and my 65 year old mother are from El Salvador and we are STILL scared of going to that corner!!! and we come from the most dangerous country in the world!

This twisted philosophy of bikes above all is not from or for Western Canada. Maintain side road or paths to allow the 1 person who wants to bike commute. Maybe for summer bike use which could switch to car use fall to spring. This insanity of permanent biking infrastructure has to stop.

Community engagement ??? why ??. Obviously from all the "bike lane" projects in downtown there is zero interest in supporting local business access. Approving developers exp just keeps people away from DT or they will drive (not bike) ie more traffic. We have more winter than summer conditions

Traffic calming measures that make it very unappealing to motorbikes and low riding cars. They represent the largest proportion of noise pollution.

Could more buffer be added in the median of the underpass to further narrow the vehicle lanes? Speeding (especially by extremely loud vehicles) is common in the downtown underpasses and makes walking or cycling through them very unpleasant.

Please pay attention to the noise level, both now and in the redesign. When I walk along 8th Ave, between 4th and 5th St SW, the signal that blares when vehicles are exiting from the underground car park are extremely load, I dare say above what a noise bylaw allows or should allow. Best if removed.

Like I said, Calgary is so unpleasant to walk in, even in supposedly neighbourhoods like Kensington and Inglewood are basically unbearable due to street noise (incl. loud buses and motorcycles), thin, obstructed sidewalks, and numerous traffic lights to get through. Anything to help would be great.

My final notes are to type 3 and 4 locations.

- 3: Do not underestimate the blank wall spaces. These can be made into productive outdoor room-type places. The blank wall should be a canvas for city artists.
- 4: These locations are in danger of becoming dead zones. Care should be taken in their design.

As a wheelchair user, I have concerns over the yellow textured impediments that are increasingly apppearing at crosswalks. As you can imagine, it's like going over a cattleguard. You cannot hit it with enough speed safely while also having enough momentum to get up the curb easily. Pls Stop.

Please consider redesigning the intersections as well as the blocks and parks. Intersections are the biggest pain points for walking and cycling, and they are where most accidents occur. I would love to see proper redesigns of them to go along with the other great proposals here.

Continuous cycle tracks, separated from pedestrians, are critical for effective movement of people in this space. Consider raised crossings at as many intersections as possible.

I'm begging you not to make the traffic worse. Removing a car lane would really impact traffic. Focus on a nice bike path, left turn lanes, traffic light timing. You can make the nicest space but if people can't get there efficiently, they won't come.

Revitalizing park spaces and creating safer bike infrastructure is critical for creating a more liveable city and for revitalizing our downtown as a whole.

Thank you for including safe, separated wheeling space from the Bow River to 17 Av.

Bike lane the entire length of the corridor is the most important part of this project to me.

This would become a major north/south corridor for cycling, replacing the function of 7th St, which terminates at 8th Ave and has terrible light timing so it's awful to bike on - you have to stop at every avenue. 8th st should not repeat this mistake.

I support any increase in separated walkways and green space, as these areas always encourage more pedestrian/bike use and sense of community. If you build it, they will come!

I walk this street daily to work, and these changes will be welcome. Right now the street is too auto-oriented. This is a great adaptation of the existing streetscape.

If the City can pull this off, i think it may make for a good template for other N/S streets - like 5th? or 11th?

Please do this project as proposed in the concept and strongly consider redesigning more streets downtown and the beltline in a similar way. Great work on the redesign

I am happy with the direction this project is now taking. Previously I thought it was too car focused, but now I am hopeful that the city is finally listening about increasing accessibility for walking and wheeling.

This is going to be such a massive improvement. Excited to visit the Beltline more often when this is done because it will be easier and more pleasant to bike and walk to it. Can't wait!

These are huge improvements all around. I would love to see these improvements bleed into the Beltline residential neighborhoods. Traffic /crosswalk safety in those neighborhoods is an ongoing concern - especially around Connaught School.
