Study objectives

This study will identify current issues and concerns with 50 Avenue S.W. and provide future recommendations that will:

- Better accommodate people who walk, bike, take transit and drive;
- II. Improve safety for those who travel on, or live along, the corridor;
- III. Provide access to key destinations; and
- IV. Better incorporate green spaces within the road right-of-way in the study area.

Study Area:





History of 50 Avenue S.W.

- 1960s to 1990s: was envisioned as an Expressway that would provide access across the Elbow River.
- 1995 <u>GoPlan</u> reclassified 50 Avenue S.W. as a Collector Road and prohibited a river crossing.
- 2009 <u>Calgary Transportation Plan</u> reclassified
 50 Avenue S.W. as a Parkway.

Parkways focus on the integration with natural areas and give walking and cycling a higher priority.


The current right-of-way is not wide enough to implement the standard Parkway design. Therefore, this study will explore opportunities to retrofit the corridor in a way that meets the needs of the community.



Road characteristics

- 1,500 14,000 vehicles per day
- 50 km/h posted speed limit
- 13 metre wide pavement surface
- One travel lane per direction
- On-street parking on both sides
- Separated sidewalks on both sides (except in front of Glenmore Athletic Park)
- On-street bicycle route
- Utility corridor along south side
- Bus routes: 7, 13, 107, 699, 731-735


